The **Content Manager** would be responsible for managing **all** written content needs of the Marketing Team of the office of **Alumni & Corporate Relations** (OOA&CR), IIT Madras - Social Media, Website Content Writing, Blogs, Newsletter, etc. The responsibilities include: -

- **Content creation** for the office websites, social media platforms, **reviewing / editing press releases**, etc.
- **Quality check / clearance** of content, to ensure **zero** error in terms of facts, grammar, design, and other requirements of the office.
- Managing multiple tasks simultaneously.
- Working with cross-functional teams such as those involved in fund-raising, event management, sales, deployment, etc.

Desirability:

- Candidates must have **excellent English language**, **communication skills**, **both written and verbal**.
- Knowledge of **content management on social media platforms** such as Twitter, Facebook, LinkedIn, Instagram, etc.
- Knowledge of *Canva* or any other graphic design software is **highly desirable**.
- Strong interpersonal skills.
- **Eye for detail**, ability to **work with no supervision**.
